Ann informed the council that she would be attending CTASv8 training on Thursday October 9. The estimate received from Arbor Jake's Tree Service to remove the tree at the old ball park is \$550. A motion by Kinzler, second by Jacobson was approved to get a second quote and then go ahead, with the lesser of the two.

Ann also asked for permission to pay the Fergus Power Pump bill for dust control in the amount of \$3168.00 as she has not heard if there will be a reduction. The late fees have been credited and a revised bill received. Permission was given.

#### MAINTENANCE REORT

Paul talked to Milo Fisher from All-State Well Drilling. Given the time extension from MPCA, Mr. Fisher would be interested in bidding on the installation of the monitoring well. Ann will resend the request information with the new finish date. Braun has been informed of the change of date by Bob from APEX Engineering.

Paxton informed the council that he would be attending MRWA training in Bemidji on October 21.

The chemical pump (fluoride) will need to be replaced.

Paxton will also be taking Thursday, Friday and Monday off.

## **Budget & Finance**

We have received pay request #4 from Johnson Excavation in the amount of \$4,459.00. A motion by Hoff, second by Jacobson was made to not approve payment upon recommendation of the engineer until all the conditions of the project pass inspection. Ann will inform APEX Engineering.

A motion by Hoff, second by Jacobson was approved to accept the letter of engagement from Carlson Highland to conduct the audit for 2014.

#### Streets, Lighting, Parks & Recreation

Paxton informed those present that the bike- walking path was open and would only need upkeep. 5 posts have been installed to discourage vehicle traffic.

## Water & Sewer

Ann asked the council if they felt a frozen water line policy should be considered. As we had no problems last winter and as the soil is heavier than most neighboring cities, it was decided that it would not be necessary.

## **NEW BUSINESS**

After some discussion, a motion by Hoff, second by Jacobson was approved to send Scott and Wendy Brendmoen, 200 East Street North, a certified letter giving them 30 days to replace the sidewalk that was removed. A copy of the estimate will be included.

Because of some of the issues that have come up, Paul asked that the council consider approving an ordinance/policy regarding the maintenance of boulevards and that specifies property owner rights and responsibilities. Ann has done some preliminary research and will work on putting an ordinance together.

Bert recommended that the city apply for a grant from the Community Education Foundation to replace the deck at Centennial Park. Applications have to be in by November 1. Ann will talk to Scott Rocholl about getting one.

The 2015 meeting schedule was approved by motion of Kinzler, Jacobson.

As there was no further business, the meeting adjourned at 7:40 p.m.
